Resolutions

- A. A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF BROCK LAGARDA-LOYA CONSTRUCTION LLC AND APPROVING THE CONTRACT FOR THE BRIGHTON LATERAL DITCH CROSSING AT BRIDGE STREET FOR THE AMOUNT OF ONE MILLION FIVE THOUSAND TWO HUNDRED SIXTY-FIVE DOLLARS (\$1,005,265), AND AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE CONTRACT ON BEHALF OF THE CITY**

Mayor Mills read the title of the Resolution into the record.

Utilities Director Scott Olsen presented the Brighton Lateral Ditch Crossing at Bridge Street contract. A storm sewer pipe will be installed under the Brighton Lateral Ditch at Bridge Street. This will replace a small portion of the existing asbestos concrete water line with a PVC water line. The missing portion of the concrete trail will be constructed over the Brighton Lateral Ditch. There will be no service interruption to the Eastgate subdivision. Construction will take place from January 19, 2026, to March 6, 2026. Four submissions were received and all were deemed responsive. Staff recommends accepting the bid from Brock Lagarda-Loya Construction LLC for \$1,005,265.

Motion by Councilmember Green, seconded by Mayor Pro Tem Padilla, to approve Resolution 2026-02. Motion passed by the following vote:


