#### **7. ORDINANCES FOR INITIAL CONSIDERATION**

##### **A. AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ADDING ARTICLE 10-3 OF THE BRIGHTON MUNICIPAL CODE; REPEALING AND REPLACING ARTICLE 10-4 OF THE BRIGHTON MUNICIPAL CODE; ADOPTING THE MODEL TRAFFIC CODE FOR COLORADO, 2024 EDITION; AND SETTING FORTH DELETIONS, MODIFICATIONS, AND ADDITIONS THERETO**

*Mayor Pro Tem Padilla read the title of the Ordinance into the record.*

*Sergeant Greg Agho presented the Model Traffic Code 2024 Edition. In 2025 the Brighton Police Department wrote over 1400 charges into Adams County Court related to license plates, vehicle registration, and driver license status. The County court must make decisions based on what is best for all municipalities in their county. Local adoption of the Model Traffic Code will allow the city to do what is best for Brighton. Almost \$120,000 in revenue was sent to Adams County last year. A byproduct of filing these charges in the city will increase revenue for the city, the primary purpose is traffic safety in the City of Brighton. These violations also come with other charges and county court often pleads down these charges. There is also no return on the investment of the time and effort that is put into a single summons when the charges are written to the county. Updating the Code restores local accountability and control over how these cases are handled and prosecuted.*

*Assistant City Attorney Michael Davis explained that the city is proposing to add Article 10-3 to address fictitious plates, number plate violations, drove vehicle without valid driver license, and drove vehicle when license is under restraint. This will increase traffic safety. Article 10-4 is the Model Traffic Code, which is a comprehensive uniform set of motor vehicle regulations enforcement mechanisms published by the Colorado Department of Transportation adopted by the state and generally adopted by reference by municipalities. Staff is proposing to repeal Article 10-4, Model Traffic Code, 2020 Edition and replace it with the most current version, Model Traffic Code 2024 Edition. In the Deletions, Modifications, and Additions section, a clean-up was done to put everything in numerical order. No substantive changes occurred. A change was proposed to what a default is. The proposal is to allow that one can default an individual for traffic infractions, but not for traffic offenses.*

*Sergeant Agho asked that City Council consider scheduling a public hearing on March 3, 2026, for the final reading of the Ordinance if approved at first reading tonight.*

Because the city is unable to accurately read the meters, the city will mitigate the usage fees for Overland Trail Middle School. This will result in a \$98,833 waiver of fees from the Enterprise Fund.*
