1. THE FESTIVAL OF LIGHTS PARADE IS A NIGHT-TIME ELECTRIC LIGHT PARADE. EVERY PARADE ENTRY MUST MEET THE MINIMUM LIGHTING REQUIREMENTS, WHICH ARE SET FORTH IN THE RULES AND REGULATIONS. **PLEASE MAKE SURE THAT YOUR ENTRY MEETS THESE REQUIREMENTS!**
2. A SIGNED COPY OF THE ATTACHED “INDEMNIFICATION AND RELEASE AGREEMENT” MUST BE SUBMITTED WITH APPLICATIONS FOR **EQUINE/LIVESTOCK ENTRIES ONLY**. A SIGNED AGREEMENT WILL BE REQUIRED FOR EACH RIDER AND/OR DRIVER IN THE ENTRY. WE ALSO RECOMMEND THAT YOU INSURE YOUR ANIMAL(S) FOR HEALTH AND LOSS, THE CITY OF BRIGHTON WILL NOT BE RESPONSIBLE FOR ANY INJURY, SICKNESS, DISEASE, DEATH, AND/OR PROPERTY LOSS OR DAMAGE TO YOUR ANIMAL DURING THIS EVENT.
3. MOTORIZED ENTRIES: PROOF OF INSURANCE AND A VALID DRIVER’S LICENSE FOR ALL DRIVERS MUST BE SUBMITTED WITH EACH PARADE ENTRY FORM.
4. A COMPLETE ENTRY FORM INCLUDES THE FOLLOWING DOCUMENTATION: COMPLETED (SIGNED) APPLICATION, INDEMNIFICATION/RELEASE AGREEMENT FOR EQUINE/LIVESTOCK ENTRIES (IF REQUIRED), DRIVER’S LICENSE/INSURANCE INFORMATION (IF REQUIRED), AND A SHORT NARRATIVE DESCRIBING YOUR ENTRY. **PARADE ENTRY FORMS WILL NOT BE CONSIDERED COMPLETE UNTIL ALL REQUIRED DOCUMENTATION IS RECEIVED.**
5. SANTA AND MRS. CLAUS TRADITIONALLY ARRIVE ON THE LAST ENTRY OF THE PARADE (SPONSORED BY THE CITY OF BRIGHTON.)
