SECTION 1

SIGNIFICANT EVENTS

Case Report 23-3587

On June 27 just before 10 a.m. officers were dispatched to a disturbance in the 800 block of South Kuner Road where a male armed with a knife was acting aggressively. When the male was confronted by officers he refused to drop the knife and continued to act in an aggressive manner. Officers deployed a taser and were able to safely take the male into custody.

Case Report 23-3596

On June 28 around 1:30 a.m. officers responded to the 7-11 at 1012 E. Bridge St. for felony menacing that had occurred 30 minutes earlier. It was reported that two males shot off multiple rounds in the air and waved a firearm around after an argument outside the store. Officers arrested one 24-year-old male who admitted to shooting his firearm.

Case Report 23-3592

On June 27 just before 8:30 p.m. officers responded to Popeyes on Prairie Center Parkway for a crash. Upon arrival officers observed a GMC Yukon backed into the north side of the building. The driver of the vehicle reported that they accidentally put their vehicle in reverse instead of park. Building inspectors determined that the building would need to be closed down while it is repaired. There were no injuries.

Case Report 23-3632

Case Report 23-3652

On June 30 around 11:45 p.m. officers were dispatched to an animal abuse call in the 1200 block of South 8th Avenue. Upon arrival the male subject stated his dog had been hit by a car and was deceased. Officers continued to investigate and discovered that the dog was still alive in the subject's apartment. The lab puppy had multiple broken bones and internal injuries. Further investigation determined that the male subject lied and the puppy was not hit by a car but had been badly beaten. The 24-year-old male was arrested and transported to Adams County jail on charges of animal cruelty. The puppy is receiving medical treatment and is expected to survive.

Case Report 23-3659

On July 1 around 8:30 p.m. officers responded to the 3000 block of East Bridge Street on a report of gunshots. Upon arrival they learned that someone had fired a rifle at the victim's car before driving off. After investigating further officers successfully identified the suspect. Detectives are continuing to investigate this incident and the suspect is currently wanted for attempted murder.

Case Report 23-3572

On June 26 just before 12:15 p.m. officers responded to the 1800 block of Bridge Street for a crash. Officers learned that the driver of a Lexus sedan struck a juvenile riding a scooter while making a turn. The juvenile received serious bodily injury. The driver of the Lexus was issued a summons for careless driving causing injury and will be required to appear in court.
