SECTION 1

SIGNIFICANT EVENTS

Case Report 23-4022

On July 18 just before 8 a.m. in the 4800 block of Bridge Street a driver crashed into the fence at McDonalds. Upon further investigation, officers learned the driver suffered an alcohol-related seizure that caused him to lose control of the vehicle. The driver was transported to the hospital and charges in the crash are pending.

Case Report 23-4057

At 7:10 p.m. on July 19 in the 2100 block of Peregrine Drive a 47-year-old male pulled into his complex and crashed his GMC Terrain into four parked cars and a motorcycle. He was found to be very intoxicated. After being medically cleared, he was transported to Adams County jail and booked in on multiple charges for DUI and hit and run.

Case Report 23-4074

Officers conducted a traffic stop On July 20 around 11 p.m. for driving without headlights on. The driver had a nationwide extradition warrant from Santa Barbara California for Dangerous Drugs Probation Violation. He is now staying at ACDF until he can get a flight to California.

Case Report 23-4096

On July 21 just before 7 p.m. officers conducted a traffic stop for expired temp tags. They found the 55-year-old driver to have a suspended license and a warrant for her arrest. Officers found several syringes with Morphine, 5.9 grams, as well as some paraphernalia with Cocaine and Methamphetamine.



Case Report 23-4115

On July 22 at 8:46 p.m. on Highway 85 and W. Bromley Ln. a member of the Adams County Sheriff's Office aired that he witnessed a crash at the intersection involving a pedestrian. Upon arrival, officers learned that a 54-year-old male was walking east through the north side of the intersection while north and southbound Hwy 85 had green lights. He was hit by a Chevrolet Equinox. The male was transported to PVMC with serious injuries and was then transported to Lutheran. The Traffic Safety Unit was called out to investigate.

Case Report 23-4120
