## SECTION 1

# SIGNIFICANT EVENTS

### Case Report 23-4446

On Aug. 7 an individual who was stopped for traffic violations was found to be in possession of someone else's ID. Search incident arrest yielded 4.93 grams of meth. The individual is on probation for two other distribution cases already. He was arrested and transported to ACDF.

### Case Report 23-4542

On Aug. 11 at 3:53 p.m. officers observed people smoking Fentanyl beside the Kum & Go. One of them had a warrant, paraphernalia and two stolen credit cards linked to a prior vehicle trespass. The male was arrested and booked into jail on charges of criminal possession of a financial device, theft from a vehicle, and possession of drug paraphernalia.

### Case Report 23-4563

On Aug. 12 in the 200 block of South 45th Avenue officers received reports of a Dodge Charger racing up and down the street and doing donuts. When the reporting party attempted to speak with the driver they heard a gun rack so they ran inside. The car left the scene. Officers then discovered a vehicle matching the description in the parking lot of Knights of Columbus. The 18-year-old driver admits to being there on South 45th Avenue and a handgun was found in the vehicle. The 18-year-old male was arrested and booked into ACDF on Felony Menacing and Reckless Driving.



### Case Report 23-4566

On Aug 13. at approximately 2:30 in the morning, officers were on patrol in the area near South 18th Avenue and Bridge Street when they noticed a man driving a bicycle in the middle of the street without any lights on. Officers contacted the man and found him to be in possession of 52 grams of methamphetamine, 220 fentanyl pills, and some counterfeit xanax pills.

### Case Report 23-4579


On Aug. 14 officers responded to a domestic violence call in the 200 block of North 8th Avenue. The suspect was confirmed to be inside the house but refused commands to exit. SWAT was called while detectives worked on a warrant. After making announcements for over three hours, the suspect surrendered peacefully and without incident.

### Operation Full Circle

Colorado's 17th Judicial District Attorney's Office, the North Metro Task Force, and the DEA officially announced the results of Operation Full Circle, a large-scale cocaine trafficking investigation in Adams County, that led to the indictment of 31 individuals on charges under the Colorado Organized Crime Control Act as well as drug-trafficking violations. Brighton Police Department has detectives that serve on the North Metro Task Force who worked on this operation for 18 months. [Read the full news release here.](#)
