SECTION 1

SIGNIFICANT EVENTS

Case Report 23-6706, 6707

On Nov. 21 at 7:13 p.m. officers responded to a robbery with weapons occurring near the 100 block of West Longs Peak Street at Whiskey Barrel Liquor Store. It was reported that the suspect entered the store, displayed a firearm and demanded money. The suspect then fled in an unknown direction.


Moments later, at 7:17 p.m., officers were dispatched to the 12000 block of East 168th Avenue for another armed robbery. Officers believe the suspect is the same in both cases. Detectives are continuing to investigate these incidents.

Case Report 23-6712

On Nov. 22 at 4:08 a.m. officers were dispatched to a burglary in progress in the 400 block of East Bromley Lane at a vape store. The reporting party stated that a dark colored sedan backed up to the building and popped the trunk, and then the individuals broke into the vape shop and loaded merchandise into their vehicle before leaving. Officers saw a vehicle fleeing the area at a high rate of speed and attempted a traffic stop. The vehicle eluded officers, but they were able to obtain license plate information. Detectives are continuing to investigate this burglary.

Case Report 23-6684

On Nov. 22 officers were able to gather intel about distribution of drugs near the 3000 block of East Bridge Street. Several arrests were made, and they were able to write a search warrant and recover nearly 20 grams of methamphetamine and drug paraphernalia.



Case Report 23-6751

A homicide occurred at an apartment complex in the 100 block of Miller Avenue. Officers and detectives worked together to quickly arrest a suspect. [Read the full news release here.](#)


