SECTION 1

SIGNIFICANT EVENTS

Case Report 24-1196

On March 4 a 35-year-old female was arrested for child abuse after leaving her 10-year-old to watch her 1-year-old for several hours. There was no phone available to the children, nor did they know how long their mom was going to be away. The suspect had a prior child abuse warrant, and even received a car seat donation from Brighton officers in December for driving with unrestrained kids. The kids were taken into protective custody until social services responded.

Case Report 24-1236

On March 6 officers pulled over a vehicle for an expired temp tag. Upon contacting the driver, officers observed drug paraphernalia. A further search yielded approximately 7.5 grams of methamphetamine. The 32-year-old male driver and 26-year-old female passenger were arrested and jailed.

Case Report 24-1283

On March 8 at 6:48 p.m., officers were dispatched to an injury crash where a truck hit a Jeep. The large dually truck had left after hitting the Jeep and ran over a pole causing a tire to rip off. The truck, a 2006 GMC 3500, was found abandoned around South 20th Avenue and Southern Street. The driver fled on foot, and the vehicle was towed and secured. A child in the Jeep was transported to the hospital for injuries. This is an ongoing investigation.

Case Report 24-1290

On March 9 officers responded to a hit-and-run crash where a Tahoe fled the scene. The Tahoe was located by officers shortly after the crash, and there was one occupant in the vehicle. A tactical safety pin was conducted to prevent the vehicles from leaving. The occupant refused to exit the vehicle and he was removed by officers. The driver was charged with DUI, hit-and-run, violation of driver's permit, no proof of insurance, careless driving and obstruction.

Case Report 24-1322

On March 10 officers were on routine patrol in the area of Bridge Square Apartments when they observed a truck drive by smelling like marijuana. Officers cleared the plate and found it to be an active steal out of our city. Officers pinched the vehicle and conducted a high risk stop until additional officers arrived on scene. All occupants complied with orders. The 54-year-old male suspect was arrested for motor vehicle theft plus another misdemeanor charge for possession of controlled substance.
