SECTION 1

SIGNIFICANT EVENTS

Case Report 24-1492

On March 18 around 5:30 p.m. officers were dispatched to an occupied suspicious vehicle in the Prairie Center. When officers arrived on scene, a male passenger exited the vehicle and ran from police. He ran into the Office Depot where he attempted to flush drugs and paraphernalia. Officers who went after him were able to take him into custody and recover additional drugs from the vehicle he was in. He was booked into Adams County jail on multiple warrants and charges, including one count of felony tampering with physical evidence.

Case Report 24-1497

On March 19 around 2:45 a.m. officers were dispatched to an in-progress burglary at a construction site. The alarm company reported that there was a male on the property wearing all black with his face partially covered. The alarm company could see on camera that the suspect was carrying a baseball bat and forced entry through the main door. Officers arrived on scene and began to investigate. They attempted to locate the suspect in the area but he was never found.

Case Report 24-1540

On March 20 at 5:45 p.m. officers were dispatched to a shoplift in progress at Dick's Sporting Goods. Upon arrival the male suspect was seen fleeing out the front door. Officers gave chase and the suspect was arrested for shoplifting.

Case Report 24-1565

On March 22 at 3:30 p.m. officers were dispatched to a shoplift in progress at Walgreens. Officers quickly located and stopped the suspect who was trying to flee on foot. The 24-year-old male continued to fight officers, so a taser was deployed before he was safely placed into custody. The suspect was processed and booked into Adams County jail on several charges including shoplifting and obstruction.

Case Report 24-1575

On March 22 just before midnight, officers were dispatched to check on an individual who reported firing a gun inside a residence near the 200 block of North 5th Avenue. Upon arrival officers were able to confirm that nobody was injured, but the individual had barricaded himself inside the home. An emergency alert was sent out as a precautionary measure. After speaking with our crisis negotiators for several hours, the male finally exited the residence just before 5 a.m. He was taken into custody and later booked into Adams County jail on multiple weapons charges and reckless endangerment.

Case Report 24-1612

On March 24 officers conducted a traffic stop on a vehicle with damage to the front end. The driver of the vehicle appeared to be intoxicated with his 13-year-old daughter in the backseat. After further investigation, the driver was arrested for driving under the influence and child abuse.
