## SECTION 1

# SIGNIFICANT EVENTS

---

### Case Report 24-2263

On April 24 at 6 p.m. officers were dispatched to a felony menacing that occurred at Benedict Park 30 minutes earlier. The reporting party stated that the suspect pulled out a handgun and demanded him to give him his property. The victim handed over his belongings and nobody was injured. This is an active investigation, and detectives believe that the suspect and victim are known to each other.

### Case Report 24-2271

On April 25 just before 5 a.m. officers responded to reports of an occupied suspicious vehicle near the 15100 block of Brighton Road. Upon contacting the occupants and searching the vehicle, officers discovered 18 grams of methamphetamine and 36 grams of fentanyl pills. The 39-year old female suspect was released on a summons, and the 55-year-old female suspect was arrested and transported to Adams County jail.



### Case Report 24-2284

On April 25 at 3:40 p.m. officers received reports of a felony menacing near the 100 block of South 20th Avenue. The reporting party said they saw a teenage male chasing another teenage male on foot and that they were both pointing handguns at each other. One of the suspects reportedly fled in a vehicle. Officers quickly surrounded the area and contacted a vehicle matching the suspect vehicle description, but no firearms were located and they were not able to successfully identify the suspect. This is an active and ongoing investigation.

### Case Report 24-2299

On April 26 officers were dispatched to a felony menacing near the unit block of North Main Street. The reporting party, who witnessed the incident, stated the unknown victim did not remain on scene. The reporting party described the suspects as two males approximately 18-20 years of age wearing hoodies and facemasks. The taller suspect produced a handgun and pointed it to the unknown victim. The victim and suspects in this case have not been identified.

## **THIS WEEK'S CRIME PREVENTION TIP**

Don't give your personal or financial information in response to a request that you didn't expect. Honest organizations won't call, email, or text to ask for your personal information, like your Social Security, bank account, or credit card numbers. If you get an email or text message from a company you do business with and you think it's real, it's still best not to click on any links. Instead, contact them using a website you know is trustworthy. Or look up their phone number. Don't call a number they gave you or the number from your caller ID. If you were scammed or think you saw a scam, tell the FTC at [ReportFraud.ftc.gov](https://www.ftc.gov) and contact your local police department.
