SECTION 1

SIGNIFICANT EVENTS

Case Report 24- 2345

On April 29 at 9:45 a.m. officers initiated a traffic stop and the vehicle failed to stop, fleeing from officers. The vehicle was located in Commerce City approximately 15 mins later and the driver was contacted and arrested on warrants. Brighton Police Officers responded to Commerce City to positively identify the driver and take custody of her. The vehicle was found to be a reported steal out of Denver. The 37-year-old female was arrested for several charges including DUID, motor vehicle theft, vehicular eluding, and more. She was processed and booked into Adams County jail.

Case Report 24-2366

On April 30 officers noticed two parties who appeared to be ingesting narcotics in a vehicle near the Armory. Officers contacted the occupants and after the driver exited the vehicle, the passenger jumped into the driver's seat and fled from the scene. While attempting to stop the driver from stealing the vehicle, a taser was deployed. The suspect continued to drive away and crashed into another vehicle nearby. The suspect was successfully identified, and this is an active investigation.

Case Report 24-2375

On April 30 a 32-year-old suspect turned himself in on a \$100,000 drug distribution warrant. He had in his possession 148 grams (roughly 140 pills) of fentanyl. He was again charged with possession with intent to distribute and booked into Adams County jail.

Case Report 24-2263

On May 1 detectives received a tip that the suspect in this robbery from last week was seen near the intersection of Bridge Street and Main Street. Officers quickly responded to the area and when the suspect saw them, he fled on foot. Officers were able to catch up to the suspect and successfully take him into custody. He was found to be in possession of a 9mm magazine. The 18-year-old male was processed and booked into Adams County jail.

Case Report 24-2425

At 3:45 p.m. on May 2, officers were dispatched to a crash in the area of Prairie Center Parkway and Eagle Boulevard. Dispatch advised a female crashed into a light pole and fled in another vehicle. While responding to the scene, officers located the fleeing suspect and detained her. The 23-year-old female was driving a stolen vehicle, while suspected to be high on Fentanyl. She was arrested and medically cleared before being booked into Adams County jail on multiple charges for the crash, including DUID.

Case Report 24-2474

On May 5 officers received a report that an unknown suspect pulled up in a white truck and pointed a rifle at a 10-year-old girl outside an apartment complex. This is an active and ongoing investigation.

Case Report 24-2473

On May 5 officers responded to a residence for an arrest warrant. The 70-year-old suspect was taken into custody without incident. A search warrant was granted for the residence, and officers discovered one gun, 40.94 grams of Meth, and 5.1 grams of Heroin. The suspect was processed and transported to Adams County jail.

Amber Alert

Brighton Police Department issued an Amber Alert on Saturday through the Colorado Bureau of Investigation. The children were safely located in Colorado Springs and the suspect was taken into custody just over an hour after the alert was sent. [Read the full news release here.](#)
