SECTION 1

SIGNIFICANT EVENTS

Case Report 24-2657

On May 14 at 7:10 a.m. officers were dispatched to a report of a male walking in the area of Eagle Boulevard and Peregrine Drive wearing nothing but a towel. When officers attempted to contact the male to ensure he was okay, he fled on foot. About an hour later, officers received multiple additional reports of a male running on the shoulder of US Highway 85 with a stick in his hand toward the on-ramp to E470. Officers successfully deployed Bola Wrap devices to safely detain him and transport him to the hospital for further evaluation.

Case Report 24-2712

On May 17 just before 4 a.m. officers were dispatched to a domestic violence in progress. Dispatchers reported that the disturbance was taking place inside a traveling vehicle. Officers quickly responded to the area and located the vehicle. When officers initiated a traffic stop, the vehicle continued driving. Dispatchers could hear an active disturbance on the line, so officers pursued the vehicle to the area of US Highway 85 and 144th Avenue where the vehicle finally stopped. A high-risk traffic stop was performed, and the suspect exited the vehicle without issue. After investigating further, the suspect was arrested on charges of domestic violence, assault, and vehicular eluding.
