SECTION 1: SIGNIFICANT EVENTS

Case Report 24-3267

On June 12 at 4:15 p.m. dispatch received a call stating a stabbing had occurred. When officers arrived on scene, both people inside the residence refused to open the door and repeatedly told officers to leave. Officers eventually forced entry and were able to take the suspect into custody without incident. It was determined that the suspect had cut her boyfriend on the hand during an argument. The 27-year-old female was arrested and booked into Adams County jail.

Case Report 24-3275

On June 13 at about 1:30 a.m. officers received a report from a mother that her 4-year-old son had run away. Officers responded to the area and began searching for the missing child. Drones were deployed and officers received assistance from Brighton Fire Rescue and the Hudson Police Department K9 unit. Officers sent a CodeRED alert to the immediate area, and later partnered with CBI to send a statewide endangered missing alert. As daylight broke, a residence in unincorporated Adams County called 911 to report a child was located on their porch. Officers responded to the residence and contacted the child, who also attempted to flee from officers. The child was medically evaluated, and the mother received information about how to better secure the home.
