SECTION 1: SIGNIFICANT EVENTS

Case Report 24-3514

On June 25 a concerned citizen called to report a DUI driver. Officers responded to the area and successfully located the suspect vehicle. One of the responding officers is a drug recognition expert (DRE) who quickly discovered that the driver was under the influence. With the assistance of the Adams County Sheriff's K-9 unit, officers recovered over 120 grams of fentanyl inside the vehicle. This driver would still be on the road, and these drugs would still be on the streets, if the concerned citizen never made the initial phone call and gave dispatchers clear information.



Case Report 24-3520

On June 25 officers responded to reports of a male with dementia who had jumped out of the car and ran away. Officers successfully located the male, but he did not want to stop and talk to them.

Since officers were concerned for his safety, they deployed a bola wrap to immobilize him. The male then became combative and punched one of the officers in the throat. The male was transported to the hospital for medical evaluation.

Case Report 24-3544

On June 26 at 10:20 p.m. officers received reports of a crash on I-76 near 144th Avenue. A caller reported a vehicle hitting the back of their vehicle, and another witness reported seeing the at-fault driver throw beer bottles out of the window. The at-fault driver was found to be under the influence, and became combative when asked to perform roadside tests. He was handcuffed and transported to the hospital, where he became combative with medical staff. The 38-year-old male was eventually processed and transported to Adams County jail on several charges including resisting arrest, careless driving, and DUI. The interstate was closed for about one hour during this incident.
