SECTION 1: SIGNIFICANT EVENTS

Case Report 24-3811

On July 8 at 4:45 p.m. officers were dispatched to a drunk driver on US Highway 85 northbound near East 168th Avenue. The caller reported seeing the driver exit the vehicle and drop a beer can before getting back in the vehicle and driving away. Officers successfully located the suspect vehicle and conducted a traffic stop. The driver threw narcotics out of the window as officers were approaching. The 49-year-old male was found to be driving under the influence, and officers recovered approximately 30 blue fentanyl pills. The driver was arrested and booked into Adams County jail.

Case Report 24-3789

On July 8 just before 9:30 a.m. officers observed a motorcycle rider driving recklessly at excessive speeds near the 1300 block of Bridge Street. The rider attempted to flee but officers were able to catch up after he was stuck in construction traffic. When officers contacted the rider, he revved the bike and started to speed away. The officer was able to grab the rider and pull him from the bike. The rider was taken to the ground and arrested. The 32-year-old male was booked into Adams County jail on several charges.

Case Report 24-3895

At 9:40 p.m. on July 12 officers were dispatched to a medical call where a male was shot in the head with a BB gun. Witnesses reported that the female grabbed her BB gun rifle and shot him while he was walking in the street. The 63-year-old female suspect reported that she had seen the male walking around and checking door handles to cars. The female received a court summons for disorderly conduct, intentional bodily injury, and unlawful use of missiles.

Case Report 24-3876

At 1:49 p.m. on July 12 officers responded to a crash alert from an iPhone near 132nd Avenue and Sable Boulevard. When officers arrived, they found a vehicle that had been rolled over and the driver was seen leaving the area. The 19-year-old male suspect was located and he was intoxicated.

He was not cooperative and he began kicking the partition in the police vehicle. He then headbutted an officer in the head. While being transported, the suspect attempted to slip off his handcuffs. After being medically evaluated he was transported to jail on multiple charges including 2nd Degree Assault on a Peace Officer.

Case Report 24-3923

On July 14 a concerned citizen called after seeing a person passed out in the passenger seat of a vehicle with the door open. Officers responded to the area and contacted the male, who identified himself as his cousin but was positively identified and found to have a warrant. Search incident to arrest yielded over 11 grams of methamphetamine. The 34-year-old male was arrested and booked into Adams County jail. Thank you to the citizen who called to report this!
