SECTION 1: SIGNIFICANT EVENTS

Case Report 24-4724

On Aug. 20 just before 7 p.m. officers responded to Kohls for a report of theft. The suspect fled the area on a bicycle but was quickly located by officers. She attempted to flee but was successfully apprehended. Upon conducting the initial investigation, officers discovered that the 49-year-old female had stolen \$890 worth of clothing and was in possession of multiple credit cards which didn't belong to her. She was booked into Adams County jail. The 17th Judicial District Attorney's Office later accepted charges of criminal possession of a financial device, theft, and possession of drug paraphernalia.

Case Report 24-4732 and 24-4735

On Aug. 20 and Aug. 21 officers took reports of six separate burglaries. Detectives believe these are connected with over 50 burglaries across the metro area. This is an ongoing investigation.

Case Report 24-4738

On Aug. 21 Adams County Deputies called about a suspicious incident in the parking lot of the detention facility. Officers contacted two people and discovered they had fentanyl in the vehicle, they were in violation of a protection order, and that a convicted felon was in possession of a firearm.

Case Report 24-4739

On Aug. 21 officers responded to a report of animal abuse in an apartment in the 700 block of Mather Street. They learned upon arrival that property management had forced the door open and found at least one deceased animal. Community Service Officers and Patrol Officers responded and during their investigation discovered the renter, a 26-year-old male, had left the animals in the apartment for over two weeks. He was arrested and jailed on several animal cruelty charges. This is an active and ongoing investigation.

Case Report 24-4780

At 5:35 p.m. on Aug. 22, officers were dispatched to a crash at East Bridge Street and North 50th Avenue. Officers discovered that a 62-year-old female had rear-ended a 30-year-old male. The male got out of his vehicle and stood in front of the suspect's car, and the female suspect drove toward him and hit him. The suspect then drove over rocks and fled the area. Officers were able to locate her and found she was very intoxicated. She was arrested and booked into Adams County jail, and the victim received minor injuries.

Case Report 24-4789

At 10:50 a.m. on Aug. 23 officers were dispatched to a vehicle that crashed into a house in the 100 block of South 4th Avenue. A 34-year-old female was driving a BMW eastbound on Egbert Street when she entered the intersection and collided with a Honda CRV, driven by an 86-year-old male. After the collision the Honda went into the yard and hit a house. Those involved received minor injuries. This crash is still under investigation.

Case Report 24-4808
