## **SECTION 1: SIGNIFICANT EVENTS**

### Case Report 24-5093

At 11:10 a.m. on Sept. 6, officers observed a 27-year-old male who had a warrant for his arrest. The suspect saw the officers and fled on his bicycle in the area of South 4th Avenue and East Bromley Lane. Officers quickly exited their vehicle and told the suspect he was under arrest. The male continued to flee, and he ran through the property north of Kaiser. After jumping a fence, he was tased. He was quickly arrested and booked into Adams County jail.

### Case Report #24-5125

Officers were dispatched to a report of shots fired near the unit block of North 8th Avenue. The suspect vehicle had shot several times at another vehicle and fled eastbound on Bridge Street. Officers located the vehicle near Bridge Street and 50<sup>th</sup> Avenue, and they were able to follow the vehicle into Lochbuie where the driver stopped. The suspect, a 26-year-old male, was pulled out of the vehicle and placed into custody. Several spent shell casings were found inside the vehicle. The suspect was also found to be intoxicated. He was arrested on multiple charges including DUI, discharging a firearm, and prohibited use. Thank you to Lochbuie Police Department for their assistance.

### Case Report 24-5144

On Sept. 8 just after 1:15 p.m. officers received a tip about a DUI driver and they were informed that the passenger of the vehicle, a 40-year-old male, was also intoxicated and in possession of a firearm. Officers were able to locate the vehicle and conduct a traffic stop. They safely removed the firearm from the suspect before he started fighting with officers. The suspect kicked an officer and spit on another during the arrest. No officers were injured. A subsequent search of the vehicle found 56 grams of methamphetamine and nearly 10 grams of cocaine. The driver of the vehicle, a 43-year-old female, was arrested for DUI and possession with intent. This is an ongoing investigation.

## Case Report 24-5159

Dispatch reported a disturbance involving weapons, where an unidentified male was brandishing a knife and threatening bystanders. Upon arrival, officers contained the suspect on the south side of Big Lots. The suspect, wielding large knives in both hands, ignored commands and acted aggressively. For over 50 minutes, officers attempted to de-escalate the situation by deploying several less-lethal options, including bean bag rounds, pepper ball rounds, and 40mm rounds, assessing the suspect's behavior after each use. Initial efforts had little effect, but eventually, pepper ball rounds began to influence the suspect. After the third 40mm strike, he fell to the ground. Despite the knives still nearby, officers formed an arrest team and safely took him into custody without further incident.
