SECTION 1: SIGNIFICANT EVENTS

Case Report 25-0195

On Jan. 13, at about 1:00 p.m., officers located an unoccupied stolen vehicle in the Adams County Justice Center parking. Working with Courthouse security, they identified the occupants of the stolen vehicle. Two parties were arrested on auto theft charges, violation of protection orders, and possession of methamphetamine.

Case Report 25-0248

On Jan. 16, at 1:10 a.m., while on patrol near I-76 and Bromley Lane, Officer Gonzales located a vehicle traveling 101 mph. The driver was arrested for reckless driving, failing to provide proof of insurance, and driving an unregistered vehicle.

Case Report 25-0279

On Jan. 17, just before 5 p.m., Officers arrested a 38-year-old-male on charges of driving under the influence of alcohol and child abuse. The driver was involved in a hit-and-run crash in the Bromley Lane Roundabout. The other vehicle followed the suspect vehicle until police arrived. The suspect had his child in the car with him.

Case Report 25-0287

On Jan 17, at 11:00 p.m., officers were dispatched to a disturbance at an apartment near S. 18th Ave and Egbert St. When officers arrived, a known offender with an active arrest warrant jumped out of the apartment window and ran from police. The offender sustained injuries from a fall during his attempt to evade police but was eventually arrested.

Case Report 25-0304

On Jan 19, at 1:00 p.m., while on patrol in 70 W. Bridge St., officers spotted a vehicle without license plates. Officers contacted the vehicle's driver, who could not provide any identification or registration paperwork. As the officer was investigating, the driver recklessly drove away from the stop, striking another vehicle as he attempted to flee. The

vehicle did manage to get away, but the officers were able to identify the suspect. While the suspect remains at large, police are actively working on an arrest warrant for the individual.
