Waiver and Release of Liability**

By signing this form, I acknowledge and agree on behalf of myself and my heirs, executors, administrators, representatives, and assigns to hold harmless the City of Brighton, Colorado (the "City"), its officers, agents, employees, elected officials, representatives, event sponsors, and cooperating organizations, together with their respective successors and assigns (collectively, the "Sponsors") from and against any liability for injury, harm, loss, inconvenience, or damages, including, without limitation, liability arising out of or relating to any injury, harm, or loss to self or property, in connection with my participation in the 2025 CITY OF BRIGHTON BIKE RIDES.

I understand there are risks inherent with riding a bicycle, which may include, but are not limited to hazards on public rights-of-way, trails, etc., as well as other cyclists, some of whom may be inexperienced. I am voluntarily participating in this event with knowledge of the hazards involved and accept all related risks.

I represent that I am physically capable of participating in the event and the equipment I will use will be in proper and safe working condition. I further represent that I am not under the influence of any drugs or alcohol. I acknowledge that I am solely responsible for my personal health and safety, and for my personal property, whether carried by me or in a support vehicle. I understand that it is strongly recommended by the City and the Sponsors that I wear a helmet at all times during the event. I acknowledge that not wearing a helmet exacerbates the hazards associated with riding a bicycle and by choosing to not wear a helmet, I am doing so voluntarily, with full knowledge of all risks involved, and accept all related risks. I understand and acknowledge that if I leave the route during the pendency of event, I am no longer participating in the event.

I have read the event description and shall abide by all rules and regulations established by the Sponsors, including any instruction given orally by the Sponsors during the event. I understand that failure to abide by event rules and regulations established by the City and/or the Sponsors may result in my ejection from the event.
