SECTION 1: SIGNIFICANT EVENTS

Case Report 25-1701: On Mar. 30th at 12:45 p.m., Officer Torres was on patrol in the Prairie Center near the Home Depot when he noticed a vehicle with no plates parked near the back of the parking lot. Officer Torres further investigated by contacting the occupants of the car and found they were smoking narcotics in the car. The occupants were a 34-year-old female and a 47-year-old male. The individuals admitted to smoking fentanyl and powdered ecstasy. The officer seized drug paraphernalia and .98 grams of powder ecstasy.

Case Report 25-1697: On Mar. 29th at 6:15 p.m., officers were dispatched to the Safeway, 1605 E. Bridge St., on a report of unwanted people in the store. Store employees reported a couple being in the bathroom for an extended period of time and suspected them of smoking illegal narcotics. Employees also suspected the couple of shoplifting while being in the store. Officers contacted a 31-year-old male and a 27-year-old female and learned that they had been in the store concealing merchandise in an attempt to steal. The couple was also in possession of drug paraphernalia, suspected methamphetamine, and suspected fentanyl pills. They were both arrested.

Case Report 25-1680: On Mar. 28th at 9:00 p.m., officers were dispatched to Jordinelli's Sports Bar and Grill, 25 N. Main St. on reports of an intoxicated female that planned on driving away from the establishment with her children. Officers arrived and located the suspect vehicle with two young children in the vehicle without any supervision. Officers located the female across the street, speaking with a group of adults. The female reported to officers that she had been at the bar with her children from 6:30- 9:00 p.m., drinking to the point of intoxication. She also admitted leaving her children unattended at Jordinelli's while she went across the street to a different bar for about 15 minutes. Bar staff and witnesses reported the same. The female told officers she did get in her vehicle with her children, back her vehicle up, and then parked before police arrived. The female was arrested on charges of Child abuse and DUI.
