SECTION 1: SIGNIFICANT EVENTS

Case Report 25-2157: On April 23rd, at 7:35 a.m., officers were dispatched to a crash at S. Main St and Bromley involving a motorcycle and a sedan. The motorcycle was traveling west on Bromley, approaching Main St., when a vehicle made a left turn in front of it. The collision caused the motorcyclist to leave the roadway and crash into the sidewalk. The rider had a severe break in his leg and was transported to the hospital.

Case Report 25-2169: On April 23rd, at 6:00 p.m., officers were dispatched to the 100 block of N. 7th Ave on reports of gunshots. Responding officers found two deceased victims who had been shot. This is an ongoing investigation. [News Release](#)

Case Report 25-2188: On April 25th, at 11:17 p.m., officers responded to a fire alarm at Brighton Village Senior Apartments, 199 W. Southern St. Officers responded with Brighton Fire and discovered the fire was inside one of the apartments. The police and fire departments are working collaboratively to investigate this fire.

Case Report 25-2204: On April 26th, at 11:01 a.m., officers were dispatched to Carmichael Park on reports of a found child. Officers located a three-year-old girl and, through their investigation, learned she had been staying with a family member in the area. The child's mother reported that a family member who lives in the area was in charge of the child. When police attempted to contact the family member, they fled. Officers are actively looking for them to issue them a summons for child abuse.
