SECTION 1: SIGNIFICANT EVENTS

Case Report 25-4468: On August 11th, at around 7:15 p.m., officers responded to a single vehicle rollover in the area of Hwy 85 and Bromley Lane. The vehicle was in the northbound lanes of Hwy 85, and the driver, a 47-year-old male, claimed that he was forced off the road by another vehicle. Officers gathered statements from witnesses, and several citizens stated that they witnessed the crash but did not see anyone else involved. The driver was transported to Platte Valley Medical Center for further care and evaluation. The Traffic Safety Unit is handling the investigation.

SIU Arrest: On August 12th, the Strategic Impact Unit (SIU) arrested Jayson Rael, a 53-year-old male, on an active warrant related to robbery charges that occurred earlier this year at the Bomgaars. He was contacted at a family member's residence and taken into custody without incident.

Case report 25-4525: On August 14th, at around 5:10 a.m., our officers responded to a fire at a construction site in the area of South Main Street and West Bromley Lane. The call into dispatch reported a dumpster and weeds on fire. Brighton Fire Rescue responded to the scene and put out the fire. There was also a large power outage in the area, affecting nearby businesses. United Power was called to respond, as it was thought a transformer had blown up. The damage to the site and transformer is estimated at \$50,000. Our detectives are currently investigating this case.

Case report 25-4584: On August 16th, at around 5:10 p.m., our officers responded to a check well-being call in the area of North 7th Ave and East 168th Ave. They found a 55-year-old male slumped over the steering wheel of his truck at the intersection, who appeared intoxicated. His truck was not parked and was moving forward and backward when the officers arrived. Several citizens pulled over to stop him from driving by boxing in his truck with their cars. Officers started to remove the male from his vehicle to make sure that he and those around him were safe. The male resisted and fought with officers in the driver's seat. Officers were able to get the truck turned off, but the male was still resisting. The Taser was deployed, and the male was successfully placed into custody. He was transported to Platte Valley Medical Center for care and evaluation and later booked into Adams County Detention Facility on DUI charges.
