### SECTION 1: SIGNIFICANT EVENTS

**Case report 25-4632:** On August 18th, at around 6:50 p.m., our officers received a call from Lucky Luceros Bail Bonds, at 636 E Bridge St, in Brighton, stating a wanted suspect, Julio Martinez, a 33-year-old man, was in the area with a felony warrant. We were told that the suspect would be coming by the business, and it was requested that a Brighton Officer be present. When our officers arrived, they saw the suspect fleeing the area. Officers followed Martinez and stopped him near the Auto Zone at 4800 E Bridge St, after setting up a perimeter. Martinez was arrested on his warrants and taken to the Adams County Detention Facility.

**Case report 25-4657:** On August 20th, at around 9:00 a.m., Detective Sergeant Murlowski was leaving the Adams County Courthouse parking lot at 1100 Judicial Center Parkway when he spotted a possible stolen motorcycle pulling into the parking lot. He observed a male motorcyclist and a female passenger get off the bike and enter the courthouse. Sgt. Murlowski then went up to the motorcycle and confirmed that it was stolen. He notified Adams County Communications, and patrol officers responded to the scene. Officers waited at the Courthouse for the suspects to exit the building, and they were able to take them into custody without incident. The female was questioned, and it was determined that she was not involved in stealing the motorcycle, so she was released. The suspect, a 35-year-old male, was transported to the Brighton Police Department for questioning before being booked into Adams County Detention Facility. The stolen vehicle was recovered.

**Case report 25-4671:** On August 20th, at around 7:45 p.m., our officers responded to the 700 block of South 10<sup>th</sup> Ave to a disturbance where a 43-year-old man was threatening his neighbors. Officers arrived at the scene and received threats from this man as well. The man became violent and started to spray water on our officers with a garden hose. He also threw rocks at the officers and neighbors. Officers made attempts to arrest the man, but he ran into the house to escape. He exited the house a short time later, and officers snuck up on him from behind to place him into handcuffs. He was taken into custody without incident and transported to the Brighton Police Department. He was later transported to Adams County Detention Facility on the above charges, along with additional misdemeanors.

**Case report 25-4713:** On August 22nd, at around 4:00 p.m., our officers received a report of a student involved in a suspicious incident near Bromley East Charter School, at 356 Longspur Drive in Brighton. The

student was approached by an adult male who said that he was there on behalf of the student's parent to provide a ride home.

Additional information, to include a description of the adult male, is not available at this time. Our officers have increased patrols around the school, and this incident is under investigation.
