### SECTION 1: SIGNIFICANT EVENTS

**Case Report 25-5627:** On October 9th, at around 7:50 a.m., officers responded to a call for a missing person from Riverdale Rehabilitation Center, 2311 East Bridge Street. The 74-year-old male left the secure area and was reported missing by staff. Officers located him near the ditch behind the Adams County Jail; however, this area is not easily accessible. The officers were able to access a back road to get to the male's location and bring him safely back to the facility.

**Case Report 25-5645:** On October 10th, at around 4:50 p.m., officers responded to a 43-year-old female who was fleeing after shoplifting near East Bridge Street and South 20th Ave. The female had taken merchandise valued at about \$500. Ofc. Hessler also found a ledger in the suspect's possession with the items to be stolen written down. The woman was booked into the Adams County Detention Facility on municipal charges related to the shoplifting.

**Case Report 25-5661:** On October 11th, at around 4:50 p.m., our officers responded to a DUI driver in the parking lot of King Soopers, 100 North 50th Avenue. A male was seen drinking alcohol while in the driver's seat of a vehicle. When officers arrived on scene, they located the male as he was driving away. Officers initiated a traffic stop on the vehicle, and the 31-year-old male told officers that he didn't have a driver's license or insurance. The male was visibly intoxicated and subsequently arrested. He was also found to be in possession of Methamphetamine. He was booked into Adams County Detention Facility on DUI-related charges.

**Case Report 25-5662:** On October 11th, at around 6:00 p.m., officers responded to Superstar Carwash, 59 North 50th Avenue, for a hit-and-run crash. A 66-year-old male was in his vehicle in line for the carwash and drove into the back of the vehicle in front of him. The male pulled out of the carwash and took off at a high rate of speed. Shortly after the incident, the male was located at his apartment and was visibly intoxicated. After failing voluntary roadside maneuvers, he was placed under arrest for suspicion of DUI. He was brought to the Brighton Police Department and chose to take a breath test. The test showed that his Breath Alcohol Content was above the legal limit of .08. He was booked into Adams County Detention Facility for DUI-related charges.
