SECTION 1: SIGNIFICANT EVENTS

Case report 25-6232: On November 10th, at around 9:30 a.m., our officers conducted a traffic stop in the 1000 block of Judicial Center Drive on a wanted vehicle from a Flock hit. This ended with several arrests, including one 45-year-old adult male arrested for a felony possession of meth. While searching the vehicle, officers also found a black ski mask and a fake firearm. The vehicle was initially wanted out of the Commerce City Police Department for a motor vehicle theft. The 45-year-old male was booked into the Adams County Detention Facility.

Case report 25-6374: On November 16th, at around 7:20 p.m., officers responded to the 3000 block of East Bridge St. for a crash involving a truck and a car. When officers arrived on scene, they made contact with both drivers of the vehicles. The driver of the truck, a 23-year-old male, had struck a car when trying to pass. The male was asked by officers to perform roadside maneuvers to rule out a DUI. He did not pass the maneuvers and showed behaviors consistent with DUI. The male was arrested and brought to the Brighton Police Department, where he chose to take a breath test. The test showed that his Breath Alcohol Content was above the legal limit of .08. He was booked into Adams County Detention Facility for DUI-related charges.
