### SECTION 1: SIGNIFICANT EVENTS

**Case report 25-6872** : On December 13th, 2025, at around 11:45 p.m., officers responded to a prowler in progress in the 600 block of Voiles Place, where an unknown male was attempting to break into an apartment. It was later reported that the suspect was armed with a knife and attempted to stab one of the residents. When officers arrived on scene, they located and identified the 26-year-old male, who was actively assaulting one of the residents by placing them in a chokehold. Our officers deployed a Taser and were able to stop the male from continuing to assault the victim. During the investigation, it was determined that the suspect was highly intoxicated. While attempting to break into the residence, he was armed with a large kitchen knife and stabbed the front door of the apartment more than 22 times. He then proceeded to break a bedroom window, enter the residence, and make multiple statements indicating his intent to kill the residents of the home. The male was transported to the Adams County Detention Facility (ACDF) on multiple charges, including Felony Menacing, First-Degree Burglary, and Second-Degree Assault (Strangulation). On December 17th, 2025, the case was presented to the Adams County District Attorney's Office, where the following charges were successfully filed:

- 14 counts of First-Degree Burglary (while armed)
- 1 count of Second-Degree Assault (Strangulation)
- 1 count of Second-Degree Assault on a Peace Officer
- 1 count of Criminal Mischief
- 1 count of Crime of Violence
- 1 count of Crime of Violence with a Deadly Weapon
- 1 count of Child Abuse
- 1 count of Attempted Second-Degree Murder

**Case report 25-6885**: On December 14th, at around 7:10 a.m., officers conducted a traffic stop in the 300 block of E Bromley Ln of a vehicle that nearly hit a patrol vehicle. When officers made contact with the driver, a 43-year-old male, he appeared to be under the influence of a narcotic substance. The male consented to roadside maneuvers but refused a blood draw. He did not pass the roadside maneuvers and was placed under arrest. He was booked at the Adams County Detention Facility under multiple charges, including driving under the influence.
