SECTION 1: SIGNIFICANT EVENTS

Case Report 26-0392: On January 28th, at around 12:30 p.m., the Impact Team was conducting surveillance at a home in the 3000 block of E Bridge St. for a felony DV suspect. Our officers were able to determine that the suspect, a 29-year-old male, was inside the residence. At first, the male refused to come out, but he eventually exited the home and surrendered without incident. He was placed under arrest for his felony DV-related charges and transported to the Adams County Detention Facility.

Case Report 26-0476: On January 30th, at around 3:00 p.m., our officers responded to a reported phone message received by a victim. The victim stated she was stopped by the Adams County Sheriff's Office, and they told her she had a warrant out for her arrest from Brighton PD in 2023. The warrant has her listed as a transient. She stated she is not a transient and resides in a home. This case is under investigation.

Case Report 26-0471: On January 30th, at around 10:10 a.m., officers responded to a call for a suspicious incident at the 900 block of Quail Circle. The reporting party stated earlier in the morning, at around 8:50 a.m., a young male pulled up to his house in a white sedan. The male exited the vehicle and walked up the driveway and through the front yard while carrying a firearm in his hand. He was standing in the front yard and left the home soon after.
